

# **Privacy Policy**

The **Independent Living Centre Tasmania** [ILCT] is committed to providing quality services to you. This policy outlines our ongoing obligations to you in respect of how we collect and treat your personal information.

We have adopted the Australian Privacy Principles [APPs] contained in the <u>Privacy Act 1988 (Cth)</u> (the Privacy Act). This governs the way in which we collect, use, disclose, store, secure and dispose of your Personal Information.

# What is Personal Information and why do we collect it?

Personal Information is information or an opinion that identifies an individual. Examples of Personal Information ILCT collects includes names, addresses, email addresses, and phone numbers.

Personal Information is gathered in many ways including interviews, correspondence, by telephone, by email, via our website <a href="https://www.ilct.com.au">www.ilct.com.au</a>, from media and publications, from other publicly available sources, from cookies, and from third parties. ILCT does not guarantee website links or policy of authorised third parties.

ILCT collects Personal Information for the primary purpose of providing services to you, plus providing information and marketing to our clients. We may also use your Personal Information for other business purposes in circumstances where you would reasonably expect such use or disclosure, such as seeking feedback on services provided.

When collecting Personal Information, we will (where appropriate and where possible) explain to you why we are collecting the information and how we plan to use it.

## **Third Parties**

Where reasonable and practicable to do so, only Personal Information will be collected. However, in some circumstances we may be provided with information from third parties. In such cases ILCT will take reasonable steps to ensure that you are made aware of the information provided to us by the third party.

#### **Disclosure of Personal Information**

Your Personal Information may be disclosed in several circumstances including the following:

- Third parties where you consent to the use or disclosure; and
- Where required or authorised by law.

# **Security of Personal Information**

Your Personal Information is stored in a manner that reasonably protects it from misuse and loss and from unauthorized access, modification, or disclosure.

When your Personal Information is no longer needed for the purpose for which it was obtained, we will take reasonable steps to archive your Personal Information. However, most of the Personal Information is or will be stored in client files which will be kept by us for a minimum of seven (7) years and sometimes longer if mandated by government legislation.

#### **Data Breach**

A data breach happens when personal information is accessed or disclosed without authorisation or is lost. If a data breach occurs at ILCT and results in the loss or compromise of personal information, details of the event will be reported to the Office of the Australian Information Commissioner.

# **Maintaining the Quality of your Personal Information**

## **Data breaches**

The Privacy Amendment (Notifiable Data Breaches) Act 2017 requires us to let you know if your information is impacted by a data breach. This means we will tell you, if:

- there is unauthorised access to or disclosure of your information; or your information is lost, and unauthorised access or disclosure is likely to occur; and
- there is a reasonable chance that this could cause you serious harm (which can include physical, psychological, emotional, economic, or reputational harm); and
- we have been unable to remedy the situation in line with the Act.
